Using Clearnet's MyCalendar web-based tool, you can create custom reports and filter just the sources you need.

### No Sev-1s!

With hundreds of notifications flowing into your firm each week from many sources, it's easy for a notification to get lost in the shuffle. In the worst case, failure to respond to an exchange notification can lead to a "Sev-1" outage. A severity one outage means traders are completely shut out of the market by a technical failure, which might have been as simple as an IP address change that was not implemented on time. Clearnet plays a key role in preventing this scenario.

Since 1994, Clearnet has provided market data professionals with the authoritative tool for managing technical notifications from exchanges and trading services around the world. Our service is used by firms maintaining systems dependent on market data feeds. Subscribers include market data vendors, financial houses, ISVs, and trading services including exchanges, ECNs, ATs, and MTFs.

# Customize the Clearnet Calendar to Meet Your Firm's Needs

## **Clearnet Calendar, Consolidated Market Data Notifications**

The Clearnet Calendar is issued each Monday morning in .pdf format to Clearnet subscribers. First published in 1994, this Calendar is a daily diary of changes that affect market data technology, including changes to systems and networks plus related announcements that may affect them, such as tick size changes. Clearnet receives notices from exchanges on a daily basis. We select those that are relevant to professionals maintaining data feed handlers and electronic trading systems for inclusion in the Clearnet Calendar.

Most importantly, we extract target dates from each notification and post these key events to the Calendar. When those dates change (and they often do), we update the Calendar.

Each notification in the Clearnet Calendar is hyperlinked to the underlying document provided by the exchange. What results is an efficient, updated management report of planned changes to market data feeds.

## **MyCalendar, A Web-Based Tool to Create Custom Calendars**

MyCalendar is a powerful new service for Clearnet subscribers as an upgrade to the Clearnet Calendar. This web-based tool enables you to create custom calendars and inquiries. You design filters to show only the sources relevant to your firm, so you focus attention where it matters.

Functions include:

- Create one or more custom filters to report on just the exchanges you want.
- Save filters for future use. They are available on MyCalendar only to you.
- Display notifications or calendar items matching your filter.
- Create and download a .pdf of your custom Clearnet Calendar for distribution to your internal team.

## **MyPlanner, Notification Management for Market Data Professionals**

If your job requires you to stay on top of technical notifications from exchanges, market data vendors and software providers, then your firm needs Clearnet MyPlanner, the unique system that helps you manage these critical, time-sensitive announcements more effectively.
